MONUMENT SET: I held the intersection of a ancient fence line extending from the East with the centerline of County Road to the South as the corner point. At the reestablished corner point, set a 2 3/8" brass cap on a 1 1/4" x 30" galvanized iron pipe, 24" in the ground and surrounded with a mound of stone.

New accessories:

A 3/4" brass washer stamped "PLS 1106", in the North side of a power pole, 1 foot above ground level, bears South $14\ 1/2$ ° East, 29.2 feet.

A 5/8" rebar (survey control point) bears South 00°13' East, 47.9 feet.

A 5/8" x 24" rebar with a red plastic cap marked "OR PLS 1106, WA PLS 17372", in West cut bank of County Road bears S 49° W, 70.3 feet.

A 5/8" x 24" rebar with a red plastic cap marked "OR PLS 1106, WA PLS 17372" in top of bank on North side of county road bears N 85 1/2° W, 44.3 feet.

Set a steel fence post 1 ½ feet North of corner with witness sign attached. Attached bearing object signs attached to rebar accessories and power pole. (No bearing object sign on survey control point).

LOCATION AND COMMENTS: Bent over fence running East-West is 2 feet North of corner. North gate post of green gate across driveway is 11 ½ feet East. Centerline of driveway to green gate is 10 feet South. The County Road extends South and West.
