


I Commenced at the corner

 from this corner run South  
 2070 Set Post marked 1/2 for 1/2

 an aspx 4 inch brs N 53° W 80 lks  
 " " " " S 38° W 163 "  
 4000 the corner to Sec 15=16=21&22  
 Hence West var 20° E  
 2014 Set Temporary 1/8 corner  
 4027 US Field Note found No 1/4 Sec corner Set Stake for Temporary 1/4  
 8055 US " " " " Sec corner Set Temporary Stake and extend line west  
 3947 The 1/4 Sec corner bet Sec 17 & 21 making a deficiency of 50 lks  
 in the 1 1/2 miles I therefore run East on true line and at  
 3981 set Stone volcanic 8 x 10 x 22 inch for corner to Sec 16=17=20 & 21  
 Hence East

 4625 Pine Creek 75 lks wide runs East East  
 6000 Set Stake for Temporary 1/6 corner in center N 1/2 Sec 16  
 8014 Intersect North Boundary 106 lks East of 1/4 Sec corner  
 from which I run South on True line var 20° E  
 2002 Set Post marked 1/6 from which an aspx 4 inch brs N 11° W 11 lks  
 4004 the center Sec 16 a Post from which  
 an aspx 6 inch brs N 35° W 9 lks  
 6020 Set Post from which  
 an aspx 4 inches brs N 2° W 11 lks  
 The 1/6 corner in center S 1/2 Sec, 16 Hence East  
 407 Creek 25 lks wide S. E.  
 715 " 25 " " " N. E.  
 775 " 25 " " " S. E.  
 850 " 25 " " " N. E.  
 1200 " 25 " " " South  
 2000 Set Post for Temporary 1/6 corner in center S. E. 1/4  
 3125 Pine Creek 50 lks wide runs South  
 4008 Intersect East Boundary 25 lks North of 1/8 corner  
 from which I run West  
 2004 Set Post for center S. E. 1/4 Sec, 16  
 The 1/6 corner in center W 1/2 Sec 16 Hence North through NW 1/4  
 800 Co. Road N. W. 1/4 S. E.  
 1300 Creek 15 lks wide S. E.  
 1500 " 15 " " " S. W.  
 1675 " 15 " " " S. E.  
 2000 Set Stake for Temporary 1/6 corner in center NW 1/4 Sec 16  
 3850 Pine Creek 35 lks wide course S. E.  
 4002 the 1/8 corner on North Body N. W. 1/4 Sec 16 from which I run  
 South var 20° 10' E  
 2001 Set Post for center N. W. 1/4 Sec 16 from which  
 an aspx 5 inches diameter brs S 61° E 32 lks distant
