


Surveyed for J.L. Poe Thos. William Neville & William Pres. Oct 7 1889

For the re-establishment of Original U.S. Survey Section and 1/4 section corners and the subdivision of sections 5=6=7 & 8 in Township 2 South of Range 39 East of Willamette Meridian



I Commenced at the corner to sections 5=6=31 & 32 on the Township line N 71° 18' 20" S. Hence South Var 19° 45' E
