of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, in the State of Oregon,
to-wit: A strip of land One Hundred feet wide, being Fifty (50) feet on each
side of the center line of said road; as surveyed over and across

The Northeast quarter of the Northeast quarter of Section 29 Township 1st North, Range 35 East W. M. Beginning at a point designated as station 1420 + 00 on said center line survey, said point being approximately 1466 feet west and 860 feet south of the section corner common to sections 29, 31, 33 and 39 T 1 N R 35 EWM; thence south 26 degrees 43' east a distance of 650 feet to a point designated as station 1426 + 50 on said center line survey, said point being approximately 1169 feet west and 1441 feet south of the above described section corner. This parcel of land contains 0.72 acres, more or less.

In addition to the above described right of way this deed grants the privilege of obtaining additional road material from any point within 300 feet on either side of the said center line survey. Provided no timber shall be removed from without the right of way strip of 100 feet wide.

To Have and to Hold the same, unto the County of Umatilla, State of Oregon, for the purpose of a public road forever.
