to-wit: A strip of land 60 feet wide, being 30 feet on  
side of the center line of said road, as surveyed over and across

All that part of the property of Peter Xedes in the north  $\frac{1}{2}$  of section 20 T. 5 N. R. 30 E.W.M. within a strip of land 60 feet wide, being 30 feet on each side of the center line of the Pendleton Gold Springs Highway, as surveyed and staked across said property, said center line being more particularly described as follows: Beginning at a point known and designated as station 147 + 00, said point being approximately 85 feet west and 424 feet south of the section corner common to sections 17-18-19 and 20, Tp. 5, N. R. 30 E.W.M; thence south  $63^{\circ} 19'$  east a distance of 1037.9 feet; thence on a  $2^{\circ}$  curve to the right a distance of 244.2 feet; thence south  $58^{\circ} 26'$  east a distance of 3517.9 feet to a point known and designated as station 195 + 00, said point being approximately 1250 feet west and 2509 feet north of the section corner common to sections 20-21-28 and 29, Tp. 5 N. R. 30 E.W.M. said parcel of land containing 6.10 acres, more or less.
