IN THE MATTER OF OREGON ROAD,

Known as the Cold Springs- Pendleton Highway.

KNOW ALL MEN BY THESE PRESENTS, That Margaret M. Guerrant, Roy A. Thorne & LeRoy Thorne, her husband, Floyd Guerrant and Grace Guerrant, his wife, Eunice Mitchell & John C. Mitchell, her husband, Kyle H. Guerrant, single, Wade G. Guerrant, single, Anna Guerrant, single (being all the heirs of W. L. Guerrant, deceased) and Rilda Guerrant, single, Goldman, of the County of Umatilla in the State of Oregon in consideration of the benefits and other valuable considerations and the sum of One Dollar, paid Umatilla County, Oregon, the receipt whereof is hereby acknowledged, have granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, in the State of Oregon, to-wit:

All the property of W. L. Guerrant heirs in the NE^{1/4} of the NE^{1/4} of section 32 T 5 N R 31 E.W.M. within a strip of land 60 feet wide, being 30 feet on each side of the center line of the Pendleton Cold Springs Highway as surveyed and staked across said property, said center line survey being more particularly described as follows: Beginning at a point on said center line survey known and designated as station 628 7' 00, said point being approximately 70 feet north and 2095 feet west of the section corner common to sections 28- 29- 32 and 33, T 5 N R 5 E.W.M.; thence south 66° 18' east a distance of 655.3 feet; thence on a 6 degree curve to the left a distance of 468.6; thence north 85° 35' east a distance of 136.8 feet; thence on a 6 degree curve to the right a distance of 294.7 feet; thence south 76° 44' east a distance of 339.9 feet; thence on a 1 degree curve to the right a distance of 1026.7 feet to a point known and designated as station 657 7 22.0, said point being approximately 685.0 feet south and 690 feet east of the section corner common to sections 28- 29- 32 and 33, T 5 N. R. 31 E.W.M. said parcel of land containing 2.86 acres, more or less.

TO HAVE AND TO HOLD the same, unto the County of Umatilla, State of Oregon, for the purpose of a public road forever.
