the Southeast Quarter of the Southwest Quarter of Section 34 Township 5 North Range 31 East W. M. S. 46 deg. 26' E. to Station 741 + 55, a point on the said center line survey approximately 250.0 feet West of the N. E. Cor. S. E.  $\frac{1}{4}$  of the S. W.  $\frac{1}{4}$  sec. 34 T. 5 N. R. 31 E. W. M., thence S. 46 deg. 26' E. 240.8 feet, thence on a ten deg. curve to the right 109.2 feet to Station 745 + 05.0 a point on the said center line survey approximately 250.0 feet South of the N. E. Cor. of the S. E.  $\frac{1}{4}$  - S. W.  $\frac{1}{4}$  sec. 34 T. 5 N. R. 31 E. W. M., thence on a ten degrees curve to the right, said parcel of land containing 0.48 acres more or less.
