WHEREAS, in accordance with ORS 368.341(1)(c), the Umatilla County Board of Commissioners received and accepted a petition to vacate a portion of George Street, a platted public road located in the Southwest ¼ of Section 7, Township 2 North, Range 32 E.W.M. in the Town of Doris, now Rieth, and

WHEREAS, pursuant to ORS 368.346, the Board of Commissioners directed the Public Works Director to prepare and file a written report including a recommendation as to whether the vacation would be in the public interest, and

WHEREAS, the Director of Public Works, after reviewing the proposed action, has recommended that the road be vacated, and

WHEREAS, in accordance with ORS 368.346(2), the Board of Commissioners held a public hearing on December 3, 2014, to consider the proposed vacation and finding it to be in the public interest to vacate the road.

NOW THEREFORE, the Board of Commissioners orders that:

1. The portion of George Street described as follows is vacated:

A 30-foot wide road located in the Southwest ¼ of Section 7, Township 2 North, Range 32 E.W.M., being more particularly described as beginning at the Southwest Corner of Lot 12, Block 5, Town of Doris; thence northeasterly along the south line of Block 5 a distance of 165.05 feet, more or less, to the Southeast Corner of Lot 9 Block 5; thence southeasterly at right angles to said south line of Block 5 a distance of 30 feet, more or less, to the north line of Block 3, Town of Doris; thence southwesterly along the north line of Block 3 a distance of 165.05 feet, more or less, to the Northwest Corner of Lot 15, Block 3; thence northwesterly at right angles to said north line of Block 3 a distance of 30 feet, more or less, to the place of beginning.

2. Ownership of the vacated right of way shall vest as provided in ORS 368.366 in the rightful owner holding title according to law by extension of the person's abutting property boundaries to the center of the vacated property.
