WHEREAS, pursuant to ORS 368.341, the Umatilla County Board of Commissioners received and accepted a petition from owners of 100 percent of the abutting property, to initiate proceedings to vacate Eleventh Street, a Public Road originally platted in the 1909 Hermiston Orchards Subdivision and located in the Southwest Quarter of Section 12, Township 4 North, Range 28, E.W.M., and

WHEREAS, pursuant to ORS 368.346, the Board of Commissioners directed the Public Works Director to prepare and file a written report including a recommendation as to whether the vacation would be in the public interest, and

WHEREAS, the Director of Public Works, after reviewing the proposed action, has recommended that the road be vacated, and

WHEREAS, ORS 368.351 allows a county governing body to vacate public property without holding a public hearing if the petition to vacate contains signatures of 100 percent of owners of property abutting a proposed vacation.

NOW THEREFORE, the Board of Commissioners orders that:

- 1. Eleventh Street in its entirety, as originally platted in the 1909 Hermiston Orchards Subdivision, filed in Book 2, Page 81, Umatilla County Plat Records, Umatilla County Records, is vacated.
- 2. Ownership of the vacated right of way shall vest as shown on the attached vacated right of way ownership drawing, except that the United States Bureau of Reclamation and the Hermiston Irrigation District shall retain all easement or ownership rights they currently have where their canals cross the vacated right of way.
