11th Street (Hermiston Orchards) Revised Vacation Report

Issue

Nancylynn Joynes, the owner of Tax Lot 802, submitted a petition in February, 2010 to vacate a portion of 11th Street through her property. She has since spoken with the other property owners who own land adjacent to the road and they also wish to have the road vacated. A new petition has been submitted with all of the property owners' signatures to vacate the entire road from East Highland Avenue to Newport Avenue. A copy of the petition is attached

Planning Issues

Clint Spencer, City of Hermiston Planner, was again contacted regarding any concerns the City may have about future impacts of vacating the road. His reply is attached and states that they have none.

Vacation Without Hearing

ORS 368.351 allows a county governing body to vacate a road if 100% of abutting property owners sign the petition. Since 100% of the abutting property owners have signed the petition and based on the City of Hermiston's comments, it is recommended that a determination be made without holding a public hearing.

Recommendation

The Road Department recommends that the road be vacated, as it has never been used since it was platted in 1909 and no future need is anticipated for it. The Public would be benefitted by the addition of 1.33 acres to the tax rolls. Attached is a photograph showing the current condition of the road right of way at the south (East Highland Avenue) end. 
