11th Street (Hermiston Orchards) Vacation Report

History

11th Street was platted as a portion of Hermiston Orchards in 1909. Its southerly terminus is Highland Avenue and its northerly terminus is Newport Avenue which was platted as a part of the Highland Summit development. 11th Street was never actually constructed, probably due to the fact that an expensive bridge would be needed to cross the Maxwell Canal and other public roads are available for property access.

Issue

Nancylynn Joynes is the owner of Tax Lot 802 (Parcel 1 of Partition Plat 1994-30) on Tax Map 4N 28 C. It is bisected by 11th Street. She intends to divide it into two parcels and desires to have the road vacated, as it is of no use to her or area property owners. A petition meeting the requirements of ORS 368.341 was submitted to the Road Department and a copy is attached.

Planning Issues

Clint Spencer, City of Hermiston Planner, was contacted regarding any concerns the City may have about future impacts of vacating the road. His reply is attached and basically states that they have none.

Vacation Without Hearing

ORS 368.351 allows a county governing body to vacate a road if 100% of abutting property owners sign the petition. Nancylynn Joynes owns the property on both sides and based on the City of Hermiston's comments, it is recommended that a determination be made without holding a public hearing.

Recommendation

The Road Department recommends that the road be vacated, as it has never been used since it was platted in 1909 and no future need is anticipated for it. The Public would be benefitted by the addition of 0.43 acre to the tax rolls.




