WHEREAS, pursuant to ORS 368.341, the Umatilla County Board of Commissioners, through its Public Works Director, received and accepted a petition, signed by 100 percent of the abutting property owners, to initiate proceedings to vacate a portion of Robnett Street, a platted public road in Sand Bur Rancho Addition in Section 16, Township 5 North, Range 28 E.W.M., and

WHEREAS, pursuant to ORS 368.346, the Board of Commissioners directed the Public Works Director to prepare and file a written report including a recommendation as to whether the vacation would be in the public interest, and

WHEREAS, the Director of Public Works, after reviewing the proposed action, has recommended that the road be vacated, and

WHEREAS, ORS 368.351 allows a county governing body to vacate public property without holding a public hearing if the petition to vacate contains signatures of 100 percent of owners of property abutting a proposed vacation:

NOW THEREFORE the Board of Commissioners orders that the following described road is vacated:

The westerly 30 feet of Robnett Street, being more particularly described as all of Robnett Street lying west of the northerly extension of the centerline of Division Street (now vacated).

IT IS ALSO ORDERED that pursuant to ORS 368.366(2), ownership of the entire right-of-way vacated by this order shall vest in John and Janet Lamb, owners of Parcel 2 of Partition Plat 1994-34, except that a blanket easement is reserved to the City of Umatilla across the entire vacated road for maintenance and repair of its sewer and water facilities.
