PETITION FOR VACATION W. 2nd Street For Bill Kik

SECTION IV

HOW PROPERTY IS USED: Bare Ground

CONDITION OF PROPERTY: The plated street is not an improved street. The ground is of natural terrain of which the south end of the street in question is of a steep incline next to tax lot 1900 on Map 5N 28 27BD and would not be suitable for a street. The ground is covered with sagebrush and cheat grass, except for the portion of the street abutting tax lot 2200 and 1901 where lawn and locust trees run parallel in the plated street 15 feet west of these 2 lots property lines. I own all the property on both sides of the street in question, except for tax lot 2400 which is owned by Charles Tracts Water Co., Inc. This lot contains a well for Charles Tracts. I am the manager for the community water system and the Corporation is owned by Charles Kik.

REASON FOR VACATION: I would like to build a 35 X 46 Storage Shed on tax lot 2200. Where I would like to locate this shed, and be compatible with the existing building that are on site, the building would be located approximately one foot into 2nd street.

The zoning of this property on the east side of 2nd street is RSC and on the west side of the street is LI. If in the future this property would be used according to these zonings the plated lots are to small. They would have to be made into larger lots which would be accessible by W. 3rd Street, Birtrand St., Robnett St., and Hwy 395.

Charles Tracts Water Co. Inc. has an existing water line that is located and runs parallel within 20 feet of the west side of 2nd street that would be vacated. The vacation of this street is subject to an easement for this water line. This easement would also serve as an access to tax lot 2400.
