NOW THEREFORE, BE IT AND IT HEREBY IS ORDERED AND ADJUDGED that "A" Street, shown in red on the assessor's plat map of Hat Rock Tracts, which is attached hereto, and by this reference incorported herein and made a part hereof be, and the same is, hereby vacated and that all right and title thereto subject to the rights of all

public and private utility companies or easements or record, does hereby vest in the owner of the land abutting the vacated property by extension of the person's abutting boundaries to the center of the vacated property, in accordance with Oregon law.

The county surveyor is directed to mark the plat as provided under ORS 271.230 and copies of the order be recorded with the county clerk, county surveyor, and county assessor.
